In accordance with the "Act for Securing the Proper Operation of Worker Dispatching Undertakings and Improved Working Conditions for Dispatched Workers" going into force on September 30, 2015, following its revision by the "Act for Partial Revision of the Act for Securing the Proper Operation of Worker Dispatching Undertakings and Improved Working Conditions for Dispatched Workers" (Act No. 73 of 2015), the distinction between the "general worker dispatching undertakings" and the "specified worker dispatching undertakings" has been eliminated.
