1. Details of the Proposed Changes

Up until now, the "software development business" and the "embedded software development business" have been two reportable segments of the Company. However, aiming for full-scale growth of the digital solutions business with the execution of the "Medium-Term Management Plan 2023," the first year of which is the fiscal year ending March 31, 2022, the Company has decided to change the reportable segments to the two reportable segments of the "IT services business" and the "digital solutions business" from the fiscal year ending March 31, 2022 (from April 1, 2021 to March 31, 2022).
